

Notice on data sharing

Dear Kongsberg customer,

Thank you for deciding to buy a Kongsberg cutting table equipped with the latest iPC software.

Please note, that your Kongsberg cutting table provides Kongsberg Precision Cutting Systems Belgium, BV, registered address at Kortrijksesteenweg 1087-B, 9051 Ghent, Belgium (furthermore referred to as "Kongsberg") with certain production and status data. Kongsberg hereby informs you of the following:

I. Scope of data provided to Kongsberg

Your Kongsberg cutting table provides Kongsberg, on regular basis, with the following data:

Identified in a separate data sheet, available at www.kongsbergsystems.com

Kongsberg does not collect any personal data (with the meaning as defined by GDPR). Furthermore, Kongsberg does not collect the actual design files used to cut your products using a Kongsberg cutting table.

II. Data transfer

The data as identified below are transferred to Kongsberg using the following methods:

Sharing by automated e-mail service

Dedicated electronic interface

III. Use of data

Kongsberg uses the data for following purposes:

- Real time and on-demand monitoring of Kongsberg cutting table status, condition of the machine and possible need for repairs
- Statistical information on utilization of the machine
- Any service performed on the machine
- Remote and on-site diagnostics
- Other possible uses, as required by Kongsberg, within limitations provided by EU and national law.

IV. Safekeeping of data

Kongsberg utilizes the following measures, processes and tools to ensure the data collected from your Kongsberg cutting table remains secure:

Access to all data is protected by Multi-Factor Authentication and enabled on a need-to-know basis to Kongsberg employees under NDAs only.

The data collected is transferred to Kongsberg using the following protocols and data formats:



Sharing by automated e-mail service

Dedicated electronic interface

The data collected is then stored in the following manner:

Data is stored in a dedicated database, protected by MFA access on a need-to-know basis.

The data collected is secured using the following security measures:

Data is stored in a dedicated database, protected by MFA access on a need-to-know basis.

The data collected is archived and backed-up using following measures:

Data is backed up following back-up and archiving protocols applied to all data managed by Kongsberg.

Access to data collected for Kongsberg personnel is limited in the following way:

Access provided on a strict need-to-know basis only.

Kongsberg keeps the data collected for a period of 10 years.

V. Sharing of data

Kongsberg shares the data obtained from your Kongsberg cutting tables following certain limitations.

Data obtained from your Kongsberg cutting table can be shared with all entities within the Kongsberg Precision Cutting Systems group, on a need-to-know basis.

Data obtained from your Kongsberg cutting table can be shared with selected authorized distributors in your region. The scope of such data is limited to the data necessary to arrange service for your Kongsberg cutting table.

VI. Access to data

You can exercise your right to access the data obtained from your Kongsberg cutting table by reaching out to mydata@kongsbergsystems.com. Please accompany your request with the specifications of your machine including Serial Number and attach authorization for the requesting person.

Kongsberg reserves the right to charge a service fee for its response to such request to access data obtained from your Kongsberg cutting table.

VII. Use of data by third parties

In case you decide to access the data obtained from your Kongsberg cutting table, you have the right to share this data with third parties. Such third parties are allowed to use such data to develop and provide services for your Kongsberg cutting table. Please note, that Kongsberg cannot be held liable for issues, that might have been caused by such third parties and reserves the right to refuse service to any Kongsberg product affected by such use of data.

Such third parties will be asked to sign documentation based on the Model Contractual Terms as published by the European Commission in 2025, adopted to the use case at hand.



VIII. Liability

Kongsberg is not liable to you for any use of data by any third party.

Kongsbergs liability to you for any damages related to the data provided to you by Kongsberg is limited to the maximum extent permitted by applicable law.

IX. Government access

Kongsberg may be prompted by the government of which it is subject to disclose the data obtained from your Kongsberg cutting table. In case Kongsberg receives a lawful request to share such data, it will be complied with within applicable statutory deadlines.

In such situations, Kongsberg will strive to inform you of such request and its scope on a best efforts basis, unless restrained from doing so by the requesting government body.
